

Members, Amidst all the "bubble, bubble, toil and trouble", ClubMulwala, through its great staff and management team, have managed to survive 2019/20 with flying colours. Stage 1 renovations creating major interruption to operations from April through till late December, a great first quarter of 2020 and then 10 weeks closure from Covid-19, leaves a financial year no one will ever forget.

A profit of \$1,523,193 is an excellent result that should make all our members proud of our CEO Alan Rowe and his team. Together they have managed to keep everyone healthy in an environment that had so many surprises, an ever-changing landscape of on-again off-again, opening again in June with lots of restrictions on how we normally do things. Well done to all concerned, I know the Board are so proud of our dedicated staff in achieving this outcome.

I trust our members are enjoying our newly renovated Club. As I have said before, I believe we now have a superbly modern Club that puts ClubMulwala into the 'Best Club' rankings. I congratulate Richard Butler of Rubicon Design and Construct and his crew for this great outcome. It must be noted that 50% of the \$4M spent on trade installations, was spent locally. The board understands the interruption and inconvenience experienced by our members and thank them for their patience. I am sure it was well worth the wait.

I again congratulate Marg Futcher in achieving Employee of the Year for 2019 and Jade Benson for winning the annual Colin Scott Award for Excellence in Hospitality. Well done to both ladies.

This year we say goodbye to Director John Burn, who has moved to live in Rutherglen and hence is outside the radius of 30Km required of a Director. I thank John for his contribution in his 4 years as a Director, especially noting his enthusiasm for all assistance given to our schools, Tourism and the Yarrawonga Agricultural Show.

On a sad note, we lost our long-time Auditor, Jeff Haebich in November last year, after his gallant effort to attend our 2019 AGM. The Board pass on our condolences to his wife Kaye and Jeff's family. In December, after a detailed tender process, the Board appointed Johnson MME of Albury to conduct the 2020 audit of our accounts.

I congratulate our Intrahouse Clubs on their achievements over the past 12 months, with a special mention to our Lawn Bowls on winning two pennant premierships. Our annual snooker challenge was again enthralling and enjoyable, but not so successful for the Directors. Due to renovations, our Indoor Bowls is now operating in the Anzac Lounge. A new challenge in the future for Directors is to try their hand at indoor bowling. Thankyou to the hard-working committees that keep these clubs going.


ClubMulwala continue to support our local community charities and groups, donating over \$255,000 in cash and/or inkind support. This amount is less than previous years but was effected by the 10 week closure. ClubMulwala has a close allegiance with the Yarrawonga Mulwala RSL Sub-Branch and its Auxiliary, and the Cobram Yarrawonga Legacy Group and their Widows. I know that all these organisations appreciate our commitment each year.

ClubsNSW, the governing body for registered clubs, is always pushing for diversity on the membership of Boards of Directors. I have been privileged to chair the Board of ClubMulwala for the last two years, and I thank my fellow Directors, and our CEO Alan Rowe, for their contribution, commitment and support to myself and to ClubMulwala, and look forward to a safe but challenging 2020/21.

The net amount of operating profit of the Company for the year was \$1,523,193.

#### 7. DIVIDENDS PAID OR RECOMMENDED

The company has not paid or declared any dividend since the end of the previous financial year. The constitution of the company prohibits a distribution of a dividend.

The Profit from ordinary trading operations was \$1,523,193 compared with the operating profit of \$1,583,707 in the prior year.

#### 11. AFTER BALANCE DATE EVENTS

On 1 June 2020 Covid-19 restrictions were reduced to enable the Club to re-open, but with capacity and social distancing restrictions limiting the number of patrons allowed in the Club. Government policy and restrictions relating to Covid-19 continue to evolve which will continue to create a level of uncertainty over the Club' operating environment. Given the uncertainty over the period the restrictions on trading will be in force, the financial impact cannot be reliably measured at the time of issue of these financial statements.

There are no other events since the balance date to the date of this report that would have a material effect on the operations of the Club.

#### 12. FUTURE DEVELOPMENTS

ClubMulwala committed to major renovations with Rubicon Design & Construct Pty Ltd, this project has a 10 year scope (5 stages). Stage 1 Gaming / Lounge areas commenced in April 2019 – a \$6.2million project and concluded in December 2019. Future stages will be reviewed in 2021. Roof repairs will be investigated for 2020/2021 (at approx. costing of \$1million)

#### 13. ENVIRONMENTAL ISSUES

The company's operations are not subject to any significant environmental regulation under a law of the Commonwealth or of a State or Territory. The board believes that the company has adequate systems in place for the management of its environmental requirements and is not aware of any breach of those environmental requirements as they apply to the company.
